### Motivation

"How to push the implementation of the European Green Belt by landscape policy instruments?" is the title of the 2<sup>nd</sup> scientific conference of the Central Europe-project GreenNet - Promoting the ecological network in the European Green Belt.

A result of the 1<sup>st</sup> scientific conference: "The Green Belt as an European ecological network - strengths and gaps" was: The European Green Belt as an ecological network has an unique natural and cultural heritage with an emotional human and political history, meaning and power. It is a corridor with many biodiversity hotspots and connects 24 European countries and valuable landscapes.

Furthermore the relevance and need of ecological networks for biodiversity and life in a more and more fragmented, intensively used and degraded European landscape was recognized.

There are three main landscape policy fields: protection, management and planning, which have to be handled to safeguard and develop the European Green Belt.

Due to the remaining gaps of about 50% within the European Green Belt there are a lot of challenges left. How to handle them?

Therefore we are searching for answers from the European landscape policy, an exchange of landscape policies between the European partner countries in light of a common environment and landscape policy as well as for awareness raising for the European Green Belt, ecological networks and biodiversity.

# Topics of the Call for Paper

## 1. European landscape policy

- European environmental directives and their influence on landscape development:
  - The network NATURA 2000 Value for the Green Belt and is there a lack of implementation?
  - The water directive Goals for the revitalization of flood plains and rivers. Is it helpful for the Green Belt initiative?
  - EIA and strategic environmental assessment and FFHand EU-species assessment. Does is help the European Green Belt?
- Implementation of the EU biodiversity strategy to 2020: Green Infrastructure, elimination of subsidies, harmful to biodiversity & society?
- The second pillar of the common agriculture policy (greening, cultural landscape funding): Value, function and threats for the European Green Belt? Implementation of the EU biodiversity strategy? Future of agriculture?

- European Mobility and Transport Strategy: White Paper 2011 - influence of the European Green Belt and European ecological networks, cumulative landscape fragmentation? Implementation of the EU biodiversity strategy? Future of roads, transport and mobility?
- The European Landscape Convention recommendations for the GreenNet-Project

# 2. Good practice of landscape policy instruments in European (partner) countries

- Ecological Networks/Connectivity in (national?) legislation and implementation in the partner countries
- Good examples of landscape and spatial planning in the partner countries
- Impact mitigation regulation and compensation measures and how they could be used for the European Green Belt
- Land consolidation and land ownership by trust and foundations as an instrument to ensure the Green Belt
- Significant reduction of ongoing fragmentation and intensification of land use (as these are the 2 most threatening causes to ecosystems, biodiversity and life) within ecological networks/landscape

- The Economics of Ecosystems and Biodiversity (TEEB) approach: could it be helpful for the European Green Belt?
- The Brand: Green Belt, Ecotourism, Land use cooperation, organic farming, marketing projects
- Good examples of stakeholder & policy integration, chartas
- Promoting the European Green Belt? Why and how could children and young people be interested in the Green Belt?
- Green Economy Blue Economy?
- Limits of awareness raising: why reasonable people don't call on reasons and best practice!
- Biodiversity a public good? Is there a discussion in modern social, economic and legal sciences? What is the task of governments/policy in a limited Europe/world?
