Concept and Theme:

The 12th workshop of the African Good Governance Network is composed of three distinct parts.

The first two days (27-29 March) are reserved for an **introduction workshop** for the 12 new members. The introduction workshop aims at familiarising the new fellows with the DAAD and the concept and proceedings of the AGGN network. Furthermore participants will be introduced to or acquainted with the concept of good governance. Finally, the first two days offer the possibility for the new members to get to know each other.

The thematic part of the workshop concentrates on the theme of **Good Financial Governance**. Thus, the network follows up on the interfaces of politics and administration, which had already been discussed at the 2010 "Local Governance" workshop. In recent years, Good Financial Governance has become a major theme in the international governance discourse. Pushed especially by German agencies (BMZ, GIZ), the older discourse on corruption has been broadened to take into account issues such as the raising and administering of taxes, budget planning, external budget control etc. Good financial governance is thus a key factor for development. Besides the relevance of the theme for Africa, issues of financial management and corruption are also important for the individual member at their workplace as well as in everyday life. High-level guest speakers from academia, German and international institutions (Bundesrechnungshof, EITI, GIZ, Ti, etc.) will discuss various aspects of the field with the network members.

The third part of the workshop is dedicated to **network development**. The various working groups will come together to discuss and decide network development issues. Together with DAAD, a framework for AGGN-initiated projects and the connection of Senior Fellows to the network will be elaborated, as well as the transformation of the network into an e. V.

The conference will take place in Bonn (CJD Bonn), mainly to facilitate interaction with DAAD, but also because important thematic institutions such as Bundesrechnungshof are placed in Bonn.

About AGGN

The African Good Governance Network (AGGN) comprises a group of highly educated African academics who have either studied in Germany or are still studying in Germany. Due to their qualifications they can be numbered among the future decision makers dedicated to Good Governance principles in sub-Saharan Africa. AGGN fellows promote the ideas of Good Governance and help to further the process of democratisation in their home countries. The network currently consists of 50 members (growing annually by 10) from over 20 African countries. About 1/3 of the members have already returned to Africa, working in international institutions, government departments or universities.

Under the auspices of the German Federal President Horst Köhler, the German Academic Exchange Service (DAAD) created the AGGN in early 2007. By initiating this network, the DAAD wants to make a contribution to the broadening and deepening of the academic collaboration between Africa and Germany and promote future key players in the domain of Good Governance.

On behalf of the DAAD, the Arnold-Bergstraesser-Institute Freiburg organises three workshops a year on various theoretical and practical aspects related to 'Good Governance'. Senior academics, government officials and civil society representatives share their experience on a conference topic in open discussion rounds. The workshops furthermore include skills trainings and active networking with German and African institutions.


How to get there
