What is justice? According to which criteria do we judge whether something is just or unjust? What different concepts of justice are there? Which insights can the humanities, behavioral and social sciences contribute to the debate about justice?

PRIF's annual conference discusses the different notions and theories of justice. Internationally renowned natural and social scientists present their perspectives on justice during two panels.

Primatologist and behavioral scientist **Professor Frans de Waal** (Emory University Atlanta) and neurobiologist **Professor Joachim Bauer** (University of Freiburg) offer insights on the role of justice from a natural scientific perspective. **Professor Klaus Günther** (Cluster of Excellence "The Formation of Normative Orders" at Goethe University Frankfurt) comments on their presentations.

Panel II focuses on the social sciences: Sociologist **Professor Stefan Liebig** (University of Bielefeld) and political scientist **Professor Cecilia Albin** (Uppsala University, Department of Peace and Conflict Research) introduce results of empirical work on justice on social and political behavior, which is commented on by **Professor Nicole Deitelhoff** (PRIF Research Group "Contested Normativity: Norm Conflicts in Global Governance").

In their summary, **Professor Richard Ned Lebow** (King's College, London) and **Professor Harald Müller** (PRIF) reflect on the ideas presented: What conclusions can be drawn for peace research and PRIF's research program "Just Peace Governance"?
