Urbanisation and rural exodus are major challenges for the development of rural areas in Eastern Europe

Expert panel at the Global Forum for Food and Agriculture on 14 January 2016

Halle (Saale), 13 January 2016 – As part of the International Green Week 2016, the IAMO is organising an agro-political expert panel discussion in cooperation with the German Agribusiness Alliance of the Committee on Eastern European Economic Relations (OA) on 14 January 2016 at the Global Forum for Food and Agriculture (GFFA) in Berlin, Germany. At the event 'Urbanisation, Migration and Structural Change – Challenges and Strategies for Agriculture in Eastern Europe', representatives from politics, science and business will discuss how to deal with the upcoming issues of food supply in growing cities experiencing rural exodus from regions of Eastern Europe.

Currently, the role of the Russian agricultural sector is, above all, to supply cheap agricultural raw materials. Regional or local processing can, however, provide additional income for farms, improve the employment situation locally, and increase the attractiveness of the agricultural sector and agricultural value chains. Furthermore, investment and targeted support through local initiatives can promote the establishment and development of manpower along agricultural value chains, in order to attract new skilled workers, and to make underdeveloped areas of Eastern Europe more attractive. Against this backdrop, participants of the expert panel will discuss their perspectives on such changes, and the necessary economic policy measures.

In their opening speeches, IAMO Director **Prof. Dr. Thomas Glauben** and **Dr. Robert Kloos**, State Secretary of the Federal Ministry of Food and Agriculture (BMEL) will explain the general problem and associated issues concerning the development potential of rural areas in Eastern Europe.

In the following panel discussion, **Ivonne Julitta Bollow**, Head of Eastern Europe and International Affairs of the Metro Group, and **Aleksey Kiryanov**, owner of Russian sausage company "IP Kiryanov", will especially report on their practical experience and the status of regional and local products in Russia. **Prof. Dr. Martin**

years and future expectations in the Russian agricultural sector from a scientific point of view. Kerstin

Officer of FAO Regional Office for Europe and Central Asia, will be dealing with the phenomenon of rural

exodus and the problem of the decreasing number of young people in the Russian agricultural sector. Dr.

European Economic Relations (OA), will moderate the expert panel.
